*The Trunk Road (Cowbridge Road West, Cardiff)  
(No Right-Hand Turn) Order, 1970*

Notice is hereby given that the Secretary of State has made an Order under section 1 of the Road Traffic Regulation Act, 1967, as amended by Part IX of the Transport Act, 1968, the effect of which is that no person shall cause any vehicle proceeding in that length of the London—Fishguard Trunk Road (A.48), known as Cowbridge Road West in the city and county borough of Cardiff, to make a right-hand turn into Riverside Terrace.

Copies of the Order may be obtained from the Secretary, Welsh Office, Roads Division (Y Swyddfa Gymreig, Adran Ffyrdd), Graham Buildings, 139 Newport Road, Cardiff CF2 1YU, quoting the reference number RD 30/2/234/01.

If you wish to question the validity of the Order or of any provision contained therein on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act, 1967, as amended by Part IX of the Transport Act, 1968, or on the grounds that any requirement of that Act or of any instrument made under it, has not been complied with in relation to the Order, you may, within six weeks from the 3rd September 1970, apply to the High Court for the suspension or quashing of the Order.

*The Trunk Roads (Restricted Roads) (Wales) (No. 3)  
Order, 1970*

*The Trunk Roads (40 m.p.h. Speed Limit) (No. 2)  
(Wales) Order, 1970*

Notice is hereby given that the Secretary of State has made the above Orders under sections 72 (3), 73 (1) and 74 (1) of the Road Traffic Regulation Act, 1967, as amended by Part IX of the Transport Act, 1968, the effect of which is that no person shall drive any motor vehicle at a speed exceeding 30 m.p.h. on either of the lengths of road specified in Schedule 1 to this notice and that no person shall drive any

motor vehicle at a speed exceeding 40 m.p.h. on the length of road specified in Schedule 2 to this notice.

*That length of the Fishguard—Bangor Trunk Road (A.487) at Talybont in the county of Cardigan which extends:*

- from a point 31 yards north-east of the north side of its junction with the Lletty—Llwyd road (Class III) to a point 100 yards north-east of that junction; a distance of 60 yards; and
- from a point 55 yards north of the north side of its junction with the Talybont Church road to a point 38 yards south of the north side of that junction, a distance of 93 yards.

#### SCHEDULE 2

*That length of the Fishguard—Bangor Trunk Road (A.487) at Talybont in the county of Cardigan, which extends from a point 55 yards north of the north side of its junction with the Talybont Church road to a point 11 yards north of the north side of its junction with Tan-yr-allt road, a distance of approximately 229 yards.*
