## WAGES COUNCILS ACT 1959

OSTRICH AND FANCY FEATHER AND  
ARTIFICIAL FLOWER WAGES COUNCIL  
(GREAT BRITAIN)

The Ostrich and Fancy Feather and Artificial Flower Wages Council (Great Britain) hereby gives notice of its intention to submit to the Secretary of State for Employment and Productivity proposals for (1) increasing the statutory minimum remuneration set out in the Wages Regulation (Ostrich and Fancy Feather and Artificial Flower) Order 1969 (Order O.F.(42)) and (2) the revocation of Order O.F.(42). Particulars of the proposals are contained in the Wages Council's Notice O.F.(44) which may be obtained on application to the Secretary of the Wages Council at the address given below.

The Wages Council will consider any written representation with respect to the above-mentioned proposals if made to it within 14 days from 18th September 1970. Any such representation should bear the writer's address and signature and be sent to the Secretary, Ostrich and Fancy Feather and Artificial Flower Wages Council (Great Britain), 12 St. James's Square, London S.W.1. It is desirable that persons making objections should state the
