The Housing Act 1957 and the Acquisition of Land (Authorisation Procedure) Act 1946

Notice is hereby given that the Llanelli Borough Council in exercise of the powers conferred on them by the above-mentioned Acts on the 10th September 1970, made a compulsory purchase Order entitled *The Llanelli Corporation (Columbia Row/Elizabeth Street/Hedley Terrace) Compulsory Purchase Order 1970*, which is about to be submitted to the Secretary of State for Wales for confirmation, authorising them to purchase compulsorily for the purpose of Part V of the Housing Act 1957 that is to say for the purpose of providing housing accommodation the land described in the Schedule hereto.

A copy of the Order and the maps referred to therein have been deposited at the Town Clerk's Department, Town Hall, Llanelli, and may be seen there at all reasonable hours.

Any objection to the Order may be made in writing and addressed to the Secretary of State for Wales, Welsh Office, Cathays Park, Cardiff, before the 7th October 1970, and should state the grounds for objection.

INITIAL DEVELOPMENT PLAN FOR GREATER LONDON AMENDMENT NO. 116 (1970)

Land at Sherbrooke Road, Munster Road and Orbain Road, Hammersmith

Notice is hereby given that on the 20th August 1970, the Minister of Housing and Local Government amended the above Development Plan.

A certified copy of the Development Plan as amended by the Minister has been deposited in Room 592, Main Building, at County Hall, London S.E.1, and certified copies of the Development Plan as amended or certified relevant extracts thereof have been deposited at the Borough Architect and Planning Officer's Department, 233 Hammersmith Road, London W.6.

A copy of the report of the public local inquiry made by the Inspector appointed by the Minister and a Statement of Rights of Appeal to the High Court have also been deposited at the places mentioned above.

The copies or extracts of the Development Plan and the Inspector's Report and Statement so deposited

will be open for inspection free of charge by all persons interested during normal office hours.

The amendment became operative as from the 18th day of September 1970, but if any person aggrieved by it desires to question the validity thereof or of any provision contained therein on the ground that it is not within the powers of the Town and Country Planning Act 1962, or on the ground that any requirement of the Act or any regulation made thereunder has not been complied with in relation to the making of the amendment, he may, within six weeks from the 18th September 1970, make application to the High Court.

GREATER LONDON COUNCIL

PRESCRIBED ROUTE AND WAITING RESTRICTIONS

London Borough of Lewisham

Notice is hereby given that the Greater London Council are about to consider a proposal that they should make Orders under sections 6 and 84D of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, the effect of which would be in the London Borough of Lewisham:

1. To prohibit all mechanically propelled vehicles and any other vehicle the overall width of which exceeds 3 feet 6 inches from entering that length of Walpole Road which lies under the railway bridge.

2. To impose restrictions on waiting by vehicles between 8 a.m. and 6.30 p.m. on Mondays to Saturdays in:

Catford Hill (both sides) between a point opposite the party wall of Nos. 41 and 43 Catford Hill and its junction with Perry Hill;

Perry Hill

(a) the east side, between its junction with Catford Hill and the northern kerb-line of Rutland Walk;

(b) the west side, between its junction with Catford Hill and a point opposite the northernmost flank wall of No. 12 Perry Hill.

Vancouver Road (both sides) between the western kerb-lines of Blythe Vale and Perry Hill and a point 150 feet west of those kerb-lines.

The restrictions would also apply to the first 60 feet of all adjoining side roads with the exception of the north-west side of Woolstone Road.

Any restrictions similarly imposed on waiting by vehicles in the lengths of roads specified in paragraph 2 above would be revoked.

Exemptions from the restrictions specified in paragraph 2 above would be provided in the Order to permit vehicles to wait in order to pick up and set down passengers, to load and unload goods for limited periods, to carry out essential services or when used by local authorities in pursuance of statutory powers or duties.

Any representations regarding the proposal should be sent to the Traffic Commissioner and Director of Development, The County Hall, London S.E.1, by 2nd October 1970, quoting the reference PT/TD/LS.
