ROAD TRAFFIC REGULATION ACT 1967

*The Trunk Road (Bodicote, Oxfordshire)
(Prohibition of Right-Hand Turn) Order 1970*

The Minister of Transport has made an Order under section 1 of the Road Traffic Regulation Act, 1967, as amended by Part IX of the Transport Act, 1968, the effect of which is that no person shall cause any vehicle proceeding southwards in the London-Aylesbury-Warwick-Birmingham Trunk Road (A.41), at Bodicote in the Rural District of Banbury in the County of Oxford, to make a right-hand turn into Weeping Cross Road.

Any person who desires to question the validity of, or of any provision contained in, the Order, on the ground that it is not within the powers with respect to the Order conferred by the above Act, or on the ground that any requirement of, or of any instrument made under, any provision of that Act has not been complied with in relation to the Order, may within 6 weeks of the 21st September 1970, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.
