For their action as members of a helicopter crew who, having already effected two rescues from the cliffs in South Wales, were called out, in rapidly failing light, to rescue another casualty from the bottom of near-vertical cliffs, 300 feet high, at Boscastle, Cornwall. Conditions were extremely advarse and it was necessary to have out of wird Boscastle, Cornwall. Conditions were extremely adverse and it was necessary to hover out of wind, very close to the cliffs, where no lateral oscillation of the aircraft could be tolerated in spite of its tendency to "snake" in these conditions. Despite his lack of experience, Flying Officer Buckland, the captain and pilot, showed great determination and flying skill in a difficult situation. Flight Lieutenant Cavanah, the navigator and winch operator, using his considerable experience and exceptional judgment, directed the pilot, operated the winch and ensured adequate obstacle clearance.
