

Council) (No. 1) Order 1970" authorising the stopping up of the following lengths of highway:

1. That length of unclassified road, known as Coed-y-Gores Road, Cardiff, which extends from a point 100 yards north-east of the entrance to Coed-y-Gores Farm in a northerly direction for a distance of 1,000 yards;
2. That length of footpath which extends from a point on Coed-y-Gores Road, Cardiff, 10 yards north of the bridge over Nant Glandulais in a westerly direction for a distance of 13 yards; and
3. That length of footpath which extends from a point on Coed-y-Gores Road, Cardiff, 50 yards north of the bridge over Nant Glandulais in an easterly direction for a distance of 57 yards.

##### *Town and Country Planning Acts 1962 and 1968*

The Secretary of State hereby gives notice that he has made an Order under section 153 of the Town and Country Planning Act 1962 entitled "The Diversion of Highways (Llŵchwr Urban District Council) (No. 1) Order 1970" authorising the diversion of a length of unclassified road, named Gwenlais Road at Grovesend in the county of Glamorgan, to enable development consisting of the extension of a colliery waste tipping area to be carried out by the National Coal Board in accordance with planning permission granted under Part III of the said Act.

The Order involves the provision of a new length of highway which the National Coal Board have agreed to provide as the diversion and which is to be a highway maintainable at the public expense, for which the highway authority is to be the Llŵchwr Urban District Council.
