The Neath-Abergavenny Trunk Road (Aberdulais to Llandarcy) Order 1970

The Secretary of State hereby gives notice that he has made an Order under sections 7, 20 and 44 of the above Act providing:

- (a) that a road which he proposes to construct between Llandarcy and Aberdulais (including a roundabout at each end thereof) together with the new roads which he proposes to construct as link roads to the aforementioned road at Llandarcy, Neath and Aberdulais in the County of Glamorgan shall become trunk roads as from the date when the Order comes into operation, and
- (b) that the length of the Neath-Abergavenny

 County Council of Glamorgan (who will become the highway authority responsible for that length) that the new trunk roads are open for through
