Public Paths Diversion (No. 1) Order, 1970

Notice is hereby given that the above-named Order (hereinafter referred to as "the Order") made on the 3rd day of November 1970 is about to be submitted to the Minister of Housing and Local Government for confirmation or to be confirmed by the Urban District Council of Normanton as an unopposed Order.
