WATER ACT 1945

NORTH DEVON WATER (STRATTON) ORDER

Notice is hereby given that the North Devon Water Board (hereinafter referred to as "the Board") and the Stratton Rural District Council (hereinafter referred to as "the Council") are about to apply to the Minister of Housing and Local Government for an Order under section 9 (1) and sections 33 and 50 of the Water Act 1945.

The counties and districts comprised wholly or partly in the area affected by the Order are:

The County of Devon, the County of Somerset, and the County of Cornwall, the boroughs of Barnstaple, Bideford, Okehampton, Tiverton and Great Torrington, the urban districts of Bude-Stratton, Crediton, Ilfracombe, Lynton and Northam and the rural districts of Barnstaple, Bideford, Crediton, Dulverton, Holsworthy, Launceston, Okehampton, Saint Thomas, South Molton, Tavistock, Tiverton, Torrington, Stratton, Taunton and Wellington.

Copies of the draft Order have been deposited at the offices of the Board at 4 Barnfield Crescent, Exeter, and at the offices of the Council at Broadclose Hill, Bude, and may be inspected by any person free of charge at all reasonable hours during a period of twenty-eight days from the 13th November 1970.

A notice explaining the effect of the proposed Order has been or will be published in the *Western Morning News* of the 13th and 20th November 1970.
