## DEPARTMENT OF THE ENVIRONMENT

### TOWN AND COUNTRY PLANNING ACTS 1962 AND 1968

The Secretary of State for the Environment hereby gives notice that he proposes to make an Order under section 153 of the Town and Country Planning Act 1962 to authorise the stopping up of Corapton Street, Willow Grove, Beale Street, Beale Street West, Milton Street and lengths of Greenwood Road, Wilson Street and Libra Road, Plaistow, London E.13, to enable residential development, with garages and parking spaces, to be carried out by Newham L.B.C. under Part III of the said Act.

The proposed Order will require the provision of a new road and new footpaths.

During 28 days from the 27th November 1970 copies of the draft Order and relevant plan may be inspected at all reasonable hours at the Town Hall, East Ham, London E.6, and may be obtained free of charge from the Secretary of State (quoting HLL 70/L17/046) at the address stated below.

Within the above-mentioned period of 28 days, any person may be notice to the Secretary of State (Ref. HLL 70/L17/046), St. Christopher House, Southwark Street, London S.E.1, object to the making of the Order.
