and where necessary in connection with:

(c) the maintenance of roads; and
(d) the supply of gas, water and electricity.

Waiting is also permitted for funeral vehicles engaged in a funeral cortege and invalid carriages or disabled drivers vehicles displaying the appropriate disc.

(5) City of Coventry (St. Martin's Road and Droylesdon Park Road) (Prohibition of Left Hand Turn) Order 1970.

The effect of this proposed Order is to prevent vehicles turning left into Droylesdon Park Road from St. Martin's Road.

(6) City of Coventry (Tile Hill Lane/Fletcham-stead Highway service road) (Prohibition of Entry) Order 1970.

The effect of this proposed Order is to prevent vehicles entering the service road, which runs along the west side of Fletchamstead Highway, from The

the west side of Fletchamstead Highway, from Tile Hill Lane (the service road's junction with Tile Hill Lane near the Godiva Cinema). That part of the "City of Coventry (Tile Hill Lane) (Prohibition of Right Hand Turns) Order 1967" which prohibits the making of a right hand turn from Tile Hill Lane into the said service road is to be revoked.

(7) City of Coventry (Old Church Road/Spring Road) (Prohibition of Entry and Prohibition of Right Hand Turns) Order 1970.

The effect of this proposed Order is to prevent vehicles entering Old Church Road from Spring Road, and to prevent vehicles making a right hand turn from Old Church Road into Spring Road.

(8) City of Coventry (Cross Cheaping) (Prohibition of Waiting) Order 1970.

The effect of this Order is that no vehicle will be permitted to wait at any tune in part of the length and sides of the service road at the rear known

length and sides of the service road at the rear known as Cross Cheaping. This Order will be consolidated with the "City of Coventry (Various Roads) (Prohibition of Waiting) (No. 3) Order 1966" which applies at present to other lengths of road in the Central Area. Full details of the proposals are shown in the Draft Orders which together with maps showing the prohibited and restricted roads and statements of the Council's reasons for making the Orders may be examined at the Information Bureau, Council House, during normal office hours
