

over (i) an 8 feet wide strip of land commencing from a point in Mill Lane on the east side of Siston Brook

- (a) extending in a semi-circular manner to connect with Mill Lane (when improved) at a higher level
 (b) extending northwards to the footbridge at the south-west corner of O.S. Parcel No. 2767
 (ii) a 6 feet wide strip of land commencing from a point, approximately 530 feet north of Mill Lane, extending eastwards from the footpath referred to in (i)(b) above dividing and traversing the Poplar Farm Housing Estate and joining together again prior to turning north to connect with footpath PSN 5.

A copy of the confirmed Order and the map contained in it has been deposited at the Warmley Rural District Council Offices, Warmley House, Warmley, and may be inspected free of charge, between the hours of 9 a.m.—1 p.m. and 2 p.m.—5 p.m. Mondays to Fridays inclusive.

The Order became operative on the 8th January 1971 but if any person aggrieved by the Order desires to question the validity thereof or any provision contained therein on the grounds that it is not within the powers of the Town and Country Planning Act, 1968 or on the ground that any requirement of the Act or any regulation made thereunder has not been complied with in relation to the confirmation of the Order, he may, under section 178 of the Town and Country Planning Act, 1962, within 6 weeks from the date of publication of this notice make application for the purpose to the High Court.

TOWN AND COUNTRY PLANNING ACT, 1968, SECTION 94

The County of Glamorgan (Parish of Llanilid—Footpath No. 18) Public Path Diversion Order 1970

Notice is hereby given that the above-named Order (hereinafter referred to as "the Order") made on the 29th day of October 1970, was confirmed by the Glamorgan County Council as an unopposed Order, on the 4th January 1971.

The effect of the Order, as confirmed, is to divert the public rights of way running across land situate in the Parish of Llanilid and more particularly described in the Schedule annexed hereto.

PART I

Description of site of existing paths or ways

The highway to be diverted is in the Parish of Llanilid in the Rural District of Cowbridge in the county of Glamorgan, namely:

A length of footpath No. 18 from a point approximately 70 yards (65 m.) south of Garwa Farm in a southerly direction to its termination on Mynydd Ruthin Road, a distance of 270 yards (245 m.) or thereabouts, shown in a bold black line between the points A-B on the deposited plan.

PART II

Description of site of alternative highway

A 4 foot 6 inch wide footpath from a point approximately 70 yards south of Garwa Farm in a westerly, south-westerly and southerly direction to its termination on the Mynydd Ruthin Road, a point approximately 40 yards west of the Llanilid Parish boundary, a distance of 320 yards or thereabouts, shown in a broken black line between the points B-C on the deposited plan.

Description of site of existing paths or ways

The Highways to be stopped up are in the Parish of Llangan and in the Parish of Coychurch Lower in the Rural Districts of Cowbridge and Penybont respectively in the County of Glamorgan, they are:

Parish of Llangan

A length of F.P. No. 1 from a point approximately 45 yards north of its termination on Parc-newydd Road, Treoes, in a north-westerly direction to its termination at Bridleway No. 2 a distance of 80 yards or thereabouts, shown in a bold black line between points A-B on the deposited plan.

Bridleway No. 2 from its termination on Treoes Road, at Moor Mill, in a westerly direction to its termination on Treoes Moor, a distance of 135 yards or thereabouts, shown in a bold black line between points C-D on the deposited plan.

Parish of Coychurch Lower

F.P. No. 3 from its termination on the Coychurch By-Pass in a southerly and south-westerly direction to its termination at Tyn-y-pwnt Farm, a distance of 75 yards or thereabouts, shown in a bold black line between the points E-F on the deposited plan.
