The Buckinghamshire County Council (Footpath Number 33, Parish of Great Missenden) Extinguishment of Public Right of Way Order 1970.

Notice is hereby given that on the 5th January 1971, the Buckinghamshire County Council confirmed the above-named Order.

Its effect is to extinguish the public right of way commencing on the western side of London Road, Great Missenden, approximately 400 feet south of Warren Water in a westerly and south-westerly direction to the boundary of the Aylesbury to Amersham railway line, a distance of 1,000 feet.

A copy of the Order as confirmed and the map contained in it has been deposited and may be inspected free of charge at the offices of the Amersham Rural District Council, Elmodesham House, High Street, Amersham during normal office hours.

The Order became operative as from the date of confirmation, but if a person aggrieved by the Order desires to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the Highways Act 1959, as amended, or on the ground that any requirement of the Act, as amended, or any regulation made thereunder has not been complied with in relation to the Order he may under Schedule 2 to the Act, as applied by paragraph 5 of Schedule 7 to the Act, within 6 weeks from 14th January 1971, make an application for the purpose to the High Court.

Parish of St. Cuthbert Without Stopping-up of Highway

Notice is hereby given that the Cumberland County Council, the Highway Authority, intend to apply to the Magistrates' Court for the Petty Sessional Division of Cumberland Ward in the County of Cumberland sitting at The Courts, Carlisle, at 10 a.m. on Tuesday, the 2nd day of March 1971, for an Order under section 108 of the Highways Act, 1959, to stop up

The Rural District of Godstone (Footpath No. 111 Little Court Farm, Tandridge) Diversion Order, 1971

Notice is hereby given that the above Order made on 8th January 1971 is about to be submitted to the Secretary of the Department of the Environment for confirmation or to be confirmed as an unopposed Order by the Council for the Rural District of Godstone.

The effect of the Order, if confirmed without modification, will be to divert that part of public right of way No. 111 Tandridge from the Oxted-Godstone Road (A.25) opposite its junction with Barrow Green Road for a distance of approximately 305 yards to a new line starting from a point on the west side of Tandridge Lane approximately 150 yards south of its junction with the Oxted-Godstone Road (A.25) to a point approximately 250 yards west-south-west thereof to rejoin the original route.

A copy of the Order and the map contained in it has been deposited at the Council Offices, Oxted, Surrey, and will be available for inspection, free of charge, between the hours of 9 a.m. and 5.30 p.m. on any weekday except Saturday.

Any representation or objection with respect to the Order may be sent in writing to the Clerk of the Rural District Council of Godstone at the Council Offices, Oxted, Surrey, before 14th February 1971, and should state the grounds on which it is made.

If no representations or objections are duly made, or if any so made are withdrawn, the Council for the Rural District of Godstone may instead of submitting the Order to the Secretary of the Department of the Environment, themselves confirm the Order. If the Order is submitted to the Secretary of the Department of the Environment any representations and objections which have been duly made and not withdrawn will be transmitted with the Order.
