ROAD TRAFFIC ACTS

ST. ALBANS CITY COUNCIL

*The City of St. Albans (London Road—Cul-de-Sac)
(Weight Restriction) Order, 1971*

Notice is hereby given that the St. Albans City Council propose to make an Order under the Road Traffic Regulation Act, 1967, section 1, as amended by the Transport Act, 1968, (Part IX), the effect of which will be to prohibit the use by any vehicle the unladen weight of which exceeds 3 tons of that length of London Road, formerly part of the trunk road (A.6) forming a cul-de-sac to the south-west of the part of London Road (A.6) running in a north-westerly direction from the London Colney roundabout.

The Order will contain exemptions to permit such vehicles to be used to convey persons, goods or merchandise to or from any premises on or adjacent to the road, and to permit maintenance of the road also works in connection with the supply of gas, electricity and water or any telegraphic lines or any building operations or demolition.

A copy of the draft Order and map showing the proposed restrictions may be inspected at the office of the City Engineer & Surveyor, Engineering Section, 34 St. Peter's Street, St. Albans, between 9 a.m. and 1 p.m., and 2 p.m. and 5 p.m., Mondays to Fridays, and 9 a.m. to 12 noon Saturdays.
