EXPLANATORY NOTE

These regulations amend the National Insurance and Industrial Injuries (Collection of Contributions) Regulations 1948 so as to secure that, during a period when national insurance stamps are not available to the public, an employer may deduct from an employee's wages or remuneration the amount of any contribution the employer is liable to pay on the employee's behalf before the contribution is actually paid.
