## DEPARTMENT OF THE ENVIRONMENT

It is hereby notified that Regulation 2 (5) of the Goods Vehicles (Operators' Licences) (Temporary Use in Great Britain) (Amendment) Regulations 1970 (S.I. 1970 No. 1798) will come into operation on 18th February 1971, this being the date on which the Agreement on the International Carriage of Goods by Road between the United Kingdom and Norway first comes into force for Great Britain.

### TOWN AND COUNTRY PLANNING ACTS 1962 AND 1968

The Secretary of State for the Environment hereby gives notice that he has made an Order under section 153 of the Town and Country Planning Act 1962 entitled "The Stopping Up of Highways (London Borough of Croydon) (No. 1) Order 1971" authorising the stopping up of Grove Place, Adelaide Street and lengths of Handcroft Road and Albion Street, Croydon, and requiring the provision of a new Road.

Copies of the Order may be obtained free of charge, on application to the Secretary of State, St. Christopher House, Southwark Street, London S.E.1 (quoting HLL 70/L20/016) and may be inspected at all reasonable hours at Taberner House, Park Lane, Croydon.

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the above Acts or that any requirement of those Acts or of any regulation made thereunder has not been complied with in relation to the Order, may, within 6 weeks of the 4th February 1971, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.
