THE SCHEDULE

1. In clause 5 (1) the words "eighty-three" shall be substituted for the words "seventy-four", in clause 5 (2) (a) the words "thirty-seven" shall be substituted for the words "thirty-one" and in clause 5 (2) (e) the word "twelve" shall be substituted for the word "nine".

2.
