### Conservation Areas

Notice is hereby given that the Glamorgan County Council have designated as Conservation Areas the areas described below in accordance with the provi-sions of section 1 of the Civic Amenities Act, 1967:

#### Llantrisant

Land associated with the old settlement including the whole of Llantrisant Common to the north and extending to the County highway (A.4119) to the east, continuing in a southerly direction including the Graig and Pen-y-gawsi. The line continues in an easterly direction parallel to the county highway (A.437) as far as Cross Inn. Thence following the railway in a northerly direction to Nant Cwmddu to connect with the eastern boundary of the Common.

#### Parkmill

Land including the complex of the village of Parkmill and Stonemill extending in linear form straddling the County highway (A.4118) and including the wooded areas as far as field parcel number 66 to the west and field parcel number 163 in the east. to the west and field parcel number 163 in the east. The southern limit encloses all the associated wood-lands other than Northhill Wood and small wooded areas in field parcels 200A and 164. The northern boundary follows generally the boundary of field parcel 43, crossing the mill race some 60 metres north of the corn mill.
