And the petitioners by their counsel undertaking within one month of the restoration of the name of the above-named company to the register of companies (1) to forward to the Registrar of Companies as required by sections 124 and 126 of the above-mentioned Act a copy of the annual return of the said company for each of the years 1966 and 1970 and (2) to give to the Registrar of Companies as required by Section 107 of the said Act a notice of any change in the situation of the registered office of the said company

The Court ordered that the name of the above named Dandy Properties Limited be restored to the register of companies

And it was ordered that an Office Copy of this Order be delivered to the Registrar of Companies and pursuant to the above mentioned Act the said Dandy Properties Limited is thereupon to be deemed to have continued in existence as if its name had not been struck off

And it was Ordered that the petitioners the said Dandy Properties Limited and Israel Herskovic do pay to the Registrar of Companies his costs of the said petition
