CUSTOMS AND EXCISE

NOTICE OF SEIZURE UNDER THE CUSTOMS AND EXCISE ACT, 1952

Pursuant to section 275(5) of the Customs and Excise Act 1952 and paragraph 1 of the 7th Schedule thereto, the Commissioners of Customs and Excise hereby give you notice that by virtue of the powers contained in the customs and excise Acts and enactments amending those Acts, certain goods, namely One B.M.W. 2000 CA Motor Car Registration number VS 824Z imported by you in the month of December 1967 and/or imported by you in October or November 1968 have been seized as liable to forfeiture upon the grounds that:

1. the said goods being imported goods chargeable with a duty of Customs were without payment of that duty removed from their place of importation otherwise than as provided by or under the Customs and Excise Act 1952;

2. or in the alternative relief from payment of duty chargeable in respect of the said goods was afforded under Part I of the Temporary Importation (Private Vehicle Vessels and Aircraft) Regulations 1961 (S.I. 1961 No. 1525) subject to the condition inter alia that the goods would be re-exported from the United Kingdom within 12 months of the date of their importation which condition was not complied with.

3. or in the alternative relief from payment of duty chargeable in respect of the said goods was afforded under Article 1 of the Customs Duty (Personal Reliefs) (No. 2) Order (S.I. 1968 No. 1559) subject to the condition that the goods would be exported from the United Kingdom not later than 12 months from the date of their importation which condition has not been complied with.

Whereby and by force of sections 44(a) and 257 of the Customs and Excise Act 1952 and Article 5

of the Customs Duty (Personal Reliefs) (No. 2) Order 1968, the said goods are liable to forfeiture.

If you claim that the said goods are not liable to forfeiture you must within one month from the date of this notice of seizure give notice of your claim in accordance with the said Schedule to the said Act specifying the name and address of a solicitor in England who is authorised to accept service of process and to act on your behalf. In default of such notice the said goods will be deemed to have been duly condemned as forfeited and will be liable to be disposed of in such manner as the Commissioners of Customs and Excise may direct. If you make such claim within the time aforesaid, legal proceedings will be taken for the condemnation thereof.

BOLTON COUNTY BOROUGH COUNCIL

ROAD TRAFFIC REGULATION ACT 1967 COVENTRY CITY COUNCIL

City of Coventry (Barracks Car Park, Barracks Way) (Prohibition of Waiting) Order 1971
