The Secretary of State hereby gives notice that he has appointed Mr. M. R. Mullins, M.B.E., F.R.I.C.S., M.R.S.H., F.F.S., to hold a Public Local Inquiry commencing at 10 a.m. on 20th July 1971, at the Town Hall, Welshpool, in connection with the proposal by the Secretary of State to make the above Orders, notice of which was published on 6th February 1970, pursuant to the Highways Act 1959.

The first mentioned Order would provide for the construction of two major new roads, one by-passing the existing A.483 north-south Newtown—Oswestry road through the town, and the other by-passing the A.458 Dolgellau—Shrewsbury road.

The second mentioned Order would authorise the Secretary of State to stop up certain highways affected by the new roads, to improve or alter other highways and to construct new highways.

Copies of the draft Orders and of the relevant plans may be inspected free of charge at all reasonable hours at the offices of Montgomeryshire County Council, County Offices, Welshpool and Welshpool Borough Council, High Street, Welshpool.
