TOWN AND COUNTRY PLANNING ACTS 1962 AND 1968

The Secretary of State for the Environment hereby gives notice that he has made an Order under section 153 of the Town and Country Planning Act 1962 entitled "The Stopping up of Highways (County Borough of Luton) (No. 2) Order 1971" authorising the stopping up of a length of Smith's Lane, Luton, Beds.

Copies of the Order may be obtained, free of charge, on application to the Secretary of State, Department of the Environment, Divisional Road Engineer (Eastern), Lands Branch, Heron House, Goldington Road, Bedford (quoting DE 10135/1/51) and may be inspected at all reasonable hours at the Town Hall, Luton.
