CIVIC AMENITIES ACT 1967

Tynemouth Village Conservation Area

Notice is hereby given that Tynemouth County Borough Council considers that the undermentioned area of Tynemouth constitutes an area of special visual, architectural and historic interest the character and appearance of which it is desirable to preserve or enhance and has accordingly resolved that pursuant to section 1 of the Civic Amenities Act 1967, the area shown outline in red on Plan P.3005/61 and bounded:

- (a) to the north by a line running westwards from the Coast at the rear of Percy Park to the Newcastle/Tynemouth Coast Railway Line;
- (b) to the west by a line following the railway to Tynemouth Road and thence by the westerly boundary of the Oxford Street Goods Yard to the River Tyne;

be designated a Conservation Area and within this area an area outlined in blue on the said plan and bounded:

- (i) to the north by Lovaine Row (part), Back Lovaine Row (north side), Back Prudhoe Terrace

(north side), Percy Park Road (part east side), St. Oswin's Place and thence to the northern end of Tynemouth Railway Station following the rear of the existing houses in Huntingdon Place (north side) and including Nos. 1, 3, 5 and 7 Manor Road;

- (ii) to the west by Tynemouth Station frontage;
- (iii) to the south by Station Terrace, Tynemouth Road (part), Oxford Street, Northumberland Terrace and Collingwood Terrace; and
- (iv) to the east by Priors Terrace and thence by the northern boundary of Priors Park to Pier Road, thence to the cliff top above King Edward Bay at the rear of the Gibraltar Rock Public House to a point opposite Lovaine Row;

be designated an area within which special design control is to be exercised by the local planning authority in respect of existing buildings and proposed development.

A copy of the plan hereinbefore referred to is available for inspection in my office during normal office hours.
