## HIGHWAYS ACT 1959

*The Manchester City Council (Mancunian Way)  
Special Road Scheme 1968*

The Secretary of State for the Environment hereby gives notice that he has confirmed with a modification the above Scheme which was made by the Council of the City and County Borough of Manchester under sections 11 and 12 of the above Act and under section 13 of the Manchester Corporation Act 1961, and which, as confirmed, authorises the Council to provide a special road about 1 mile 250 yards in length commencing at Chester Road and terminating at Downing Street, both in the City and County Borough of Manchester, and related "slip roads", for the exclusive use of traffic of Classes 1 and 2 of the classes of Traffic set out in Schedule 4 to the said Act as amended.

Copies of the Scheme as confirmed and of the relevant plan may be inspected free of charge at all reasonable hours at the offices of the Council of the City and County Borough of Manchester at the Town Hall, Manchester 2 and at the Department of the Environment, St. Christopher House, Southwark Street, London S.E.1.

Copies of the instrument of confirmation of the Scheme, the title of which is "The Manchester City Council (Mancunian Way) Special Road Scheme 1968 Confirmation Instrument 1971" and which contains a copy of the Scheme as confirmed, can be purchased, price 3p either through any bookseller or direct from any Government bookshop (H.M.S.O.).

Any person aggrieved by the Scheme and desiring to question the validity thereof, or of any provision contained therein, on the ground that any requirement of those Acts or of any regulations made thereunder has not been complied with in relation to the Scheme, may within 6 weeks from 29th June 1971, apply to the High Court for the suspension or quashing of the Scheme or of any provision contained therein.

## ROAD TRAFFIC REGULATION ACT 1967

Notice is hereby given that the Secretary of State has made the Motorways Traffic (A.57 (M) Mancunian Way) (Speed Limit) Regulations 1971 coming into operation on 29th June 1971. (S.I. 1971/1006.) These Regulations prohibit the driving of motor vehicles at a speed exceeding 50 m.p.h. on the Mancunian Way A.57 (M). The slip roads are restricted to a speed limit of 30 m.p.h.
