NOTICE OF PUBLIC PATH ORDER

TOWN AND COUNTRY PLANNING ACT 1962

Dukinfield, Cheshire

Notice is hereby given that the Secretary of State for the Environment in exercise of the powers conferred on him by section 153 of the Town and Country Planning Act 1962 and all other powers enabling him in that behalf proposes to make an Order the effect of which will be to extinguish the footpath which runs from a point on the south side of Dewsnap Lane due south through Dewsnap Farm for a distance of 113 yards, then east-south-east for a distance of 50 yards then south-east for 365 yards and then past the bowling green and down the steps to a point on the northern side of Johnson Brook Road and to create an alternative highway in lieu. The lines and situations of the existing and proposed alternative highway are shown on the map annexed to the Order.

A copy of the draft Order and the map contained in it has been deposited at the offices of the Dukinfield Borough Council and may be inspected free of charge at the Town Hall, King Street, Dukinfield, Cheshire during normal office hours.

Any representation or objection to the draft Order may be sent in writing to the Secretary of State for the Environment, Whitehall, London S.W.1 (reference PC2/1058/151/2) not later than 30th August 1971 and should state the grounds on which it is made.
