

In the High Court of Justice (Chancery Division).—
No. 00909 of 1971

In the matter of SPARSHOLT GARAGE LIMITED
and in the matter of the Companies Act, 1948.

Notice is hereby given that by an Order made on Monday the 21st day of June 1971 upon the petition of the above named Sparsholt Garage Limited and of William Bernard Denton Foster of 23 Crouch Hill London N.4 a member of the said company on the 24th May 1971 preferred unto this Court.

And upon hearing counsel for the petitioners and for the Registrar of Companies (the respondents).

And upon reading the said petition (as amended) the affidavit of Brian Alfred Chapman the affidavit of Anita Marie Nagle and the affidavit of William Bernard Denton Foster all filed the 8th June 1971 and the exhibits in the said affidavits or some of them respectively referred to.

And there being no opposition on behalf of Her Majesty to the relief sought by the said petition as appears from the said affidavit of Anita Marie Nagle and the exhibits thereto.

And the petitioners by their counsel undertaking within one month of the restoration of the name of the above-named company to the register of companies

(1) to forward to the Registrar of Companies as required by Sections 124 and 126 of the above-mentioned Act a copy of the annual return of the said company for each of the years 1967 and 1968 and (2) to send to the Registrar of Companies as required by Section 200 of the said Act a notification of any changes among the directors of the said company or in its secretary or in their particulars.

The Court ordered that the name of the above named Sparsholt Garage Limited be restored to the register of companies.

And it was ordered that an office copy of this Order be delivered to the Registrar of Companies. And pursuant to the above mentioned Act the said Sparsholt Garage Limited is thereupon to be deemed to have continued in existence as if its name had not been struck off.

And it was ordered that the Registrar of Companies do advertise this Order in his official name in the *London Gazette*.

And it was ordered that the petitioners the said Sparsholt Garage Limited and William Bernard Denton Foster do pay to the Registrar of Companies his costs of the said petition.
