### WEST MIDLANDS GAS BOARD

#### *Alteration of Declared Calorific Value of Gas*

Notice is hereby given that in pursuance of the Gas Act, 1948, the Gas (Declaration of Calorific Value) Regulations, 1949 and the Gas (Declaration of Calorific Value) (Amendment) Regulations, 1951, it is declared that on and after 1st October 1971, the natural gas supplied from the governor station at Alrewas, Staffordshire (O.S. Plot 77) to the areas listed in the Schedule below, will be of a calorific value of 1035 British Thermal Units per cubic foot.

## ROAD TRAFFIC ACTS

### COUNTY BOROUGH OF SOUTH SHIELDS

#### *(Wood Terrace) (Prohibition of Waiting) Order, 1971*

1. The South Shields County Borough Council have made an Order under Section 1(1), (2) and (3) of Road Traffic Regulation Act, 1967, as amended by Part IX of the Transport Act, 1968.

2. This Order which comes into effect on the 30th day of August, 1971, prohibits the leaving of a vehicle on the lengths of road specified in the Schedule hereto.

3. Exceptions to the Order permit waiting for the following purposes:—

- (a) Picking up and setting down passengers;
  - (b) Loading or unloading goods;
- and, where necessary, in connection with:—
- (c) The maintenance of roads;
  - (d) The supply of gas, electricity and water.

4. The Order together with a map showing the restricted areas may be inspected at the Town Clerk's Department, Town Hall, South Shields, during normal office hours.

5. Any person who desires to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act, 1967 as amended or on the grounds that any requirement of that Act or of any instrument made under it has not been complied with in relation to the Order may, within six weeks from the 14th day of August, 1971, apply to the High Court for this purpose.

#### THE SCHEDULE

- (1) The North side of Wood Terrace from its junction with Sunderland Road to a point 490 feet North East of the East kerb of Hartington Terrace;
- (2) The South side of Wood Terrace from its junction with Sunderland Road to a point 22 feet South East of the West kerb of Hartington Terrace.

### COUNTY BOROUGH OF SOUTH SHIELDS

#### *The South Shields (Off-Street Parking Places) Traffic Regulations (Variation) Order, 1971*

### COUNTY BOROUGH OF SOUTH SHIELDS

#### *The South Shields (Lady's Walk) (Prohibition and Restriction of Waiting) Order, 1971*

*The South Shields (Mile End Road) (Number One) (Prohibition and Restriction of Waiting) Order, 1971*  
*The South Shields (Mile End Road) (Number Two) (Prohibition and Restriction of Waiting) Order, 1971*

1. The South Shields County Borough Council have made certain Orders under Sections 1 and 2 of the Road Traffic Regulation Act, 1967 (as amended).

2. The Orders which come into effect on the 30th day of August, 1971, prohibit the leaving of a vehicle on the lengths of road specified in the First Schedule hereto and prohibit the leaving of a vehicle for a longer period than two hours in any period of four hours on the length of road specified in the Second Schedule hereto.

3. Exceptions to the Orders include waiting for the following purposes:—

- (a) Picking up and setting down passengers;
  - (b) Loading or unloading goods;
- and, where necessary, in connection with:—
- (c) The maintenance of roads;
  - (d) The supply of gas, electricity and water.

4. The Orders together with a map showing the restricted areas may be inspected at the Town Clerk's Department, Town Hall, South Shields, during normal office hours.

5. Any person who desires to question the validity of the Orders or of any provision contained in them on the grounds that they are not within the powers conferred by the Road Traffic Regulation Act, 1967 as amended or on the grounds that any requirement of that Act or of any instrument made under it has not been complied with in relation to the Orders may, within six weeks from the Thirteenth day of August, 1971, apply to the High Court for this purpose.

#### THE FIRST SCHEDULE

- (1) The east side of Mile End Road for a length of 100 yards northwest from the southwest corner of St. Stephen's Churchyard;
- (2) The west side of Lady's Walk for a distance of 125 yards southwest from the junction with Mile End Road.

#### THE SECOND SCHEDULE

- (1) The west side of Mile End Road between the junction of Lady's Walk with Mile End Road and the entrance to the former St. Stephen's E.S.N. School.
