## DEPARTMENT OF THE ENVIRONMENT

### TOWN AND COUNTRY PLANNING ACTS, 1962 AND 1968

The Secretary of State for the Environment hereby gives notice that he has made an Order under section 91 of the Town and Country Planning Act, 1968, entitled "The Sheffield Parkway Extension Road Scheme (Stopping Up) Order, 1971" authorising the stopping up of Granville Hill, Low Street and lengths of Navigation Hill, Blast Lane, Wharf Street, Broad Street, Sheaf Street, Sheaf Lane, South Street, Duke Street, Granville Street, Duke Street Lane, Bernard Road, Aston Street, Nunnery Lane, Clifton Lane, Quarry Road, Waverley Lane, a footpath known as Jews Walk, a footpath off Woodbourn Road and a footpath off Hall Road, Sheffield, and requiring the provision of new highways and the improvement of an existing highway.

Copies of the Order may be obtained, free of charge, on application to the Department of the Environment, at the office of the Divisional Road Engineer, Yorkshire and Humberside Division, 6th Floor, City House, New Station Street, Leeds LS1 4JJ (quoting HLL 93/192/01), and may be inspected at all reasonable hours at the Town Hall, Sheffield.

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the above Acts or that any requirement of those Acts or of any regulation made thereunder has not been complied with in relation to the Order, may, within six weeks of the 23rd September 1971, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.

### TOWN AND COUNTRY PLANNING ACTS, 1962 AND 1968
