

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the above Acts or that any requirement of those Acts or of any regulation made thereunder has not been complied with in relation to the Order may within 6 weeks of the 30th September 1971 apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.

TOWN AND COUNTRY PLANNING ACTS 1962 AND 1968

MINISTRY OF AGRICULTURE FISHERIES AND FOOD

LAND DRAINAGE ACT 1930

North Level Internal Drainage District

Notice is hereby given that the Minister of Agriculture, Fisheries and Food, in exercise of the powers conferred upon him by sections 4 (3) and 14 of the Land Drainage Act 1930, as applied by the Water Resources Act 1963, proposes to make an Order confirming a Scheme submitted to him by the Welland and Nene River Authority, under section 4 (1) (b) of the Land Drainage Act 1930, making provision for:

- (i) the abolition of the North Level Commissioners, the Leverington, the Tydd and the Wisbech Northside Internal Drainage Boards, and the seven drainage boards within the North Level, namely: the North Level First and Newborough Internal Drainage Board, the North Level (Second District) Drainage Commissioners, the North Level (Fourth District) Drainage Commissioners, the North Level (Sixth District) Internal Drainage Board, the Postland Drainage Board, the Sutton St. Edmunds Commissioners, and the Thorney Drainage Board;
- (ii) the abolition of the drainage districts under the jurisdiction of the seven drainage boards within the North Level;
- (iii) the amalgamation of the drainage district under the jurisdiction of the North Level Commissioners with the Leverington, the Tydd and the Wisbech Northside Internal Drainage Districts to constitute the North Level Internal Drainage District;
- (iv) the constitution of the North Level Internal Drainage Board;
- (v) matters supplemental thereto or consequential thereon.

The Scheme affects lands in the Municipal Borough of Wisbech, the Parishes of Leverington, Newton, Parson Drove, Tydd St. Giles, and Wisbech St. Mary in the Rural District of Wisbech in the County of Cambridge and Isle of Ely; the City of Peterborough, the Parishes of Borough Fen, Eye, Newborough, and Peakirk in the Rural District of Peterborough, and the Parishes of Stanground North and Thorney in the

Rural District of Thorney in the County of Huntingdon and Peterborough; the Parishes of Long Sutton, Sutton St. Edmund, Sutton St. James' and Tydd St. Mary in the Rural District of East Elloe, and the Parish of Crowland in the Rural District of Spalding in the County of Lincoln—Parts of Holland.

The Scheme may affect the liability to drainage rates of properties in the areas mentioned above.

A copy of the draft Order, together with a copy of the Scheme and of the map referred to therein, has been deposited at the Offices of the North Level Commissioners, Thorney, Peterborough, PE6 0QE, at the Offices of the Leverington Internal Drainage Board, 13 South Brink, Wisbech, PE13 1JL, and at the Offices of the Ministry of Agriculture, Fisheries and Food, Room 396 Great Westminster House, Horseferry Road, London, SW1P 2AE, for public inspection during normal office hours within the period ending with 1st November 1971.

Canada: Official Certificate
