(a) east side, from 5 yards south of its junction with Grosvenor Road to 10 yards south of the southern side of its junction with Oxford Street;
(b) both sides, from 10 yards south of the southern side of its junction with Oxford Street to 26 yards south of its junction with Heath Road.

The Trunk Road (Various Streets, Stowmarket) (Restriction of Waiting) Order 1971
