The QUEEN has been pleased by Letters Patent under the Great Seal bearing date the 4th day of October 1971, to appoint the Right Honourable Charles James Dalrymple Shaw (commonly called Lord Kilbrandon), one of the Senators of the College of Justice in Scotland, to be a Lord of Asppeal in Ordinary under the Appellate Jurisdiction Act 1876, as amended by subsequent enactments, and to grant to him the dignity of a Baron for life by the style and title of BARON KILBRANDON of Kilbrandon in the County of Argy!.
