## WAGES COUNCIL

### WAGES COUNCILS ACT 1959

#### *Retail Newsagency, Tobacco and Confectionery Trades Wages Council (England and Wales)*

The Retail Newsagency, Tobacco and Confectionery Trades Wages Council (England and Wales) hereby gives notice of its intention to submit to the Secretary of State for Employment proposals for varying the provisions relating to statutory minimum remuneration set out in the Wages Regulation (Retail Newsagency, Tobacco and Confectionery) (England and Wales) Order 1971 (Order R.N.T.(48)).

Particulars of the proposals are contained in the Wages Council's Notice R.N.T.(49) which may be obtained on application to the Secretary of the Wages Council at the address given below.

The Wages Council will consider any written representation with respect to the above-mentioned proposals if made to it within 21 days from 7th October 1971. Any such representation should bear the writer's address and signature and be sent to the Secretary, Retail Newsagency, Tobacco and Confectionery Trades Wages Council (England and Wales), 12 St. James's Square, London S.W.1. It is desirable that persons making objections should state the precise nature of their objections and quote the number of the Wages Council's Notice of Proposals R.N.T.(49).

## DEPARTMENT OF THE ENVIRONMENT

### TOWN AND COUNTRY PLANNING ACTS 1962 AND 1968

The Secretary of State for the Environment hereby gives notice that he has made an Order under section 153 of the Town and Country Planning Act 1962 authorising the stopping up of lengths of Commercial Road, Greatham, Sussex, and Russell Streets, and Providence Place and parts of the Guildhall Square, Portsmouth, and requiring the provision of new highways.

Copies of the Order may be obtained, free of charge, on application to the Department of the Environment at the office of the Divisional Road Engineer South Eastern Division, "Edgeborough", 74 Epsom Road, Guildford, Surrey (quoting DSE 102/35/1/L/09) and may be inspected at all reasonable hours at the Guildhall, Portsmouth.

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the grounds that it is not within the powers of the above Acts or that any requirement of those Acts or of any regulation made thereunder has not been complied with in relation to the Order, may, within 6 weeks of the 7th October 1971, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.

### TOWN AND COUNTRY PLANNING ACTS 1962 AND 1968

The Secretary of State for the Environment hereby gives notice that he proposes to make an Order under section 91 of the Town and Country Planning Act 1968 to authorise the stopping up of lengths of the carriageways of Priory Street, Franklin Street, Washington Street, Hancock Road, St. Leonard's Street, Empson Street, Avenue Street, Bromley Hall Road, Abbott Road, Brunswick Road, Highland Street, Aberfeldy Street, Findhorn Street, Etrick Street and Desert Street, Tower Hamlets, to facilitate the movement of traffic on the Blackwall Tunnel Northern Approach Road (which is a highway to be constructed and improved in accordance with planning permission granted under Part III of the Town and Country Planning Act 1962).

During 28 days from the 8th October 1971 copies of the draft Order and relevant plan may be inspected at all reasonable hours at the Town Hall, Cambridge Heath Road, London E.2, and may be obtained free of charge from the Secretary of State (quoting TTPA 39/L5/01) at the address stated below.
