Pinner Fair

The Secretary of State for the Home Department hereby gives notice that on 1st and 12th May 1971 respectively, representations were duly made to him by the owner and by the Council of the London Borough of Harrow, that a Fair, known as Pinner Fair, has been held annually in the London Borough of Harrow on the first Wednesday after Whit-Sunday, and that it would be for the convenience and advantage of the public that this Fair should in future be held annually on the Wednesday next following the last Monday in May.
