Subject to the exemptions provided by the Order and by virtue of section 11 (4) of the Act if, on any day after the Order has come into operation, smoke is emitted from a chimney of any building within the smoke control area the occupier of that building shall be guilty of an offence and liable to a fine not exceeding £20 unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels include anthracite, coke and other carbonised fuels, gas and electricity.

If confirmed the Order will not come into operation before the 1st July 1973 or before a later date determined by the Secretary of State for the Environment. Copies of the Order and of the map referred to therein may be inspected free of charge at the Town Clerk's Office, Municipal Buildings, Hartlepool at all reasonable times during the period of 6 weeks from the 22nd October 1971.

ANGLESEY COUNTY COUNCIL

The County of Anglesey (Ffordd Glasgoed, Cemaes Bay) (Restriction of Waiting) Order, 1971

Notice is hereby given that on the 14th October 1971, the Anglesey County Council made the abovenamed Order under section 1 (1), (2) and (3) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968.

The effect of the Order is to prohibit, with certain exceptions, the waiting by vehicles between 8 a.m. and 7 p.m. on both sides of Ffordd Glasgoed, Cemaes Bay from its junction with High Street for a distance of approximately 100 metres.

The exceptions referred to will permit waiting for the purposes of (a) picking up and setting down passengers; (b) loading or unloading goods; (c) postal services; (d) funeralls, building operations, road works and mainlaying; (e) taking in petrol from any garage, and will also permit waiting by invalid
