CAERNARVON COUNTY COUNCIL

ROAD TRAFFIC REGULATION ACT, 1967

The County of Caernarvon (Llanfairfechan) Experimental Traffic Regulation Order, 1971

Notice is hereby given that the County Council of the Administrative County of Caernarvon propose to make an Order under section 9 of the Road Traffic Regulation Act 1967, as amended by the Transport Act 1968, the effect of which:

(a) will be to prohibit waiting on parts of the following roads in Llanfairfechan:

- (i) at any time
 - (a) Station Road;
 - (b) Village Road;
- (ii) between the hours of 9 a.m. and 6 p.m.
 - (a) Village Road;
 - (b) Park Road;
 - (c) Bryn Road;
 - (d) Station Road;
 - (e) Park Crescent;
 - (f) Caradog Place;
 - (g) Glamor Road;
 - (h) Plas Gwyn Road;
 - (i) Promenade;

(iii) between the hours of 9 a.m. and 6 p.m. for a longer period than 30 minutes return prohibited for one hour

- (a) Village Road;
- (b) Station Road;
- (c) Caradog Place;

(b) will be to prohibit any vehicle to proceed in the road or length of road known as Park Crescent, Llanfairfechan in the County of Caernarvon other than from its northerly junction with Station Road towards its southerly junction with that road.

The usual exceptions will be made in that part of the Order prohibiting waiting to enable the loading and unloading of goods and passengers, work in connection with building, demolition, highway and public utility undertakings.

A copy of the proposed Order and a map showing its effect, together with a statement of the Council's reasons for making the Order have been deposited at the offices of the Llanfairfechan Urban District Council, Council Offices, Llanfairfechan, and at the offices of the County Council, Shirehall Street, Caernarvon, where they may be inspected from Monday to Friday between the hours of 9 a.m. and 5 p.m.

Any person desiring to object to the proposed Order should send his objection in writing stating the grounds on which the objection is made to the undersigned by the 2nd December 1971.

CHEADLE AND GATLEY URBAN DISTRICT COUNCIL

The Urban District of Cheadle and Gatley (Church Road, Cheadle Hulme) (Restriction of Waiting) (No. 1) Order, 1971.

Notice is hereby given that the Cheadle and Gatley Urban District Council propose to make an Order under section 1 (1), (2) and (3) and 84D (1) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968.

The effect of the proposed Order will be to amend the present waiting restrictions on Church Road, Cheadle Hulme, so as to permit vehicles to wait for periods of 20 minutes in 1 hour between (A) 9.30 a.m. and 4.30 p.m. Mondays to Fridays inclusive and (B) 7 a.m. and 8 p.m. on Saturdays, on that part of Church Road, Cheadle Hulme, extending from the westerly boundary of No. 19 to the easterly boundary of No. 25.

Exceptions will permit waiting for the purposes of:

- (a) picking up and setting down passengers;
- (b) loading or unloading goods;
- (c) the removal of furniture;
- and, where necessary, in connection with
- (d) the maintenance of roads; and
- (e) the supply of gas, electricity and water; and
- (f) invalid carriages and disabled persons.

Full details of these proposals are in the draft Order which, together with a map showing the restricted area and a statement of the Council's reasons for proposing to make the Order, may be examined at the Clerk of the Council's Department, Town Hall, Cheadle, between the hours of 8.45 a.m. and 5.30 p.m. on weekdays.
