*Town and Country Planning Acts 1962 and 1968*

The Secretary of State for Wales hereby gives notice that he has made an Order under section 153 of the Town and Country Planning Act 1962, to authorise the stopping up of that length of Treharne Road (otherwise known as Pen Treharne Road), Morriston at Swansea, which extends from a point 5 yards north of its junction with Rock Terrace to a point 36 yards north of that junction to enable development to be carried out by the Swansea County Borough Council. The Order also requires a footpath to be provided between Rock Terrace and Treharne Road.
