1. to forward to the Registrar of Companies as required by Sections 124 and 126 of the Companies Act, 1948 a copy of the annual return of the company for each of the years 1965, 1966, 1967, 1968, 1969 and 1970 together with the documents annexed thereto as required by Section 127 of the said Act.

2. to give to the Registrar of Companies as required by Section 107 of the Companies Act, 1948 a notice of any change in the situation of the company's registered office.

3. to send to the Registrar of Companies as required by Section 200 of the Companies Act, 1948 a notice of any changes in the company's directors or its secretary or in their particulars on Form 9A in the Companies (Forms) Order 1949.

The Court ordered that the name of the above-named Kashem Properties Limited be restored to the register of companies.

And it was ordered that an office copy of this Order be delivered to the Registrar of Companies and pursuant to the above-named Act the said Kashem Properties Limited is to be deemed to have continued in existence as if its name had not been struck off.

And it was ordered that the Registrar of Companies do advertise this Order in his official name in the "London Gazette".

And it was ordered that the petitioners the said Kashem Properties Limited and Barry Anthony Watts, Sarah Alice Kashem and Frederick Abu Kashem do jointly and severally pay to the Registrar of Companies his costs of the said petition such costs to be on the High Court Scale and to be taxed, if not agreed.
