TOWN AND COUNTRY PLANNING ACTS 1962 AND 1968

Mineral Workings Act 1951

The Secretary of State for the Environment hereby gives notice that he proposes to make an Order under section 153 of the Town and Country Planning Act 1962 and section 32 of the Mineral Workings Act 1951, to authorise the temporary stopping up for a period of one year of a length of Longstone Moor Road and lengths of Footpaths Nos. 14, 18, 22 and 28, at Longstone, Derbyshire, to enable development consisting of open cast mineral extraction to be carried out in accordance with planning permission granted to Messrs. A. E. Arthurton & Co.

The proposed Order will require the provision of a temporary new footpath maintainable at the public expense for which the highway authority is to be the Derbyshire C.C. and a new road and the restoration of the stopped up lengths of road and footpaths at the end of the period.

During 28 days from the 29th October 1971 copies of the draft Order and relevant plan may be inspected at all reasonable hours at the Bakewell R.D.C. Offices, Bath Street, Bakewell, and at the address of the Clerk to the Great Longstone Parish Council, Sunnybank, Great Longstone, and may be obtained free of charge from the Divisional Road Engineer (quoting DEM 10035/1/018) at the address stated below.

Within the above-mentioned period of 28 days, any person may by notice to the Secretary of State at his address at the office of the Divisional Road Engineer (Ref. DEM 10035/1/018), Cranbrook House, Cranbrook Street, Nottingham, NG1 1EX, object to the making of the Order.
