At about 1.15 a.m. on 17th April 1971, Police Constables No. 90 Dames, No. 744 Clarke and No. 762 Scavella, who were on mobile patrol, were diverted to investigate a break-in at a commercial building in the Freeport area.

As they got out of the patrol car on arrival at the scene, a man rushed from the building and the three officers gave chase. The suspect turned and fired a pistol at the three Constables, who took cover. As the suspect started to run again.
