

Bills Act, 1877, and the National Loans Act, 1968, to the amount of £100,000,000.

2. The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000, £100,000 or £250,000. They will be dated at the option of the tenderer on any business day from Monday, the 6th December 1971, to Friday, the 10th December 1971, inclusive, and will be due 91 days after date.

3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000, and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being a multiple of one new half-penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House or Broker.

6. Notification will be sent on the same day as Tenders are received, to the person whose Tenders are accepted in whole or in part. Payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or by draft or cheque drawn on the Bank of England not later than 1.30 p.m. on the day on which the relative Bills are to be dated.

7. Members of the House of Commons are not precluded from tendering for these Bills.

8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.

9. The Lords Commissioners of Her Majesty's Treasury reserve the right of rejecting any Tenders.

The QUEEN has been pleased to approve the award of the Colonial Police Medal for Gallantry to Corporal Earl Ashton Herbert Burnette of the Royal Dominican Police Force.

On 8th August 1969, a Land Rover jeep left Roseau, Dominica, carrying a Government pay-roll amounting to more than D.\$6,000. There were six persons on board, including Corporal E. A. H. Burnette, the police escort, who was armed with a revolver and five rounds of ammunition.

Some 25 miles out of Roseau, in thick forest, the jeep was forced to stop by an obstruction of trees placed across the road. As one of the passengers began to move the obstruction, a masked man, armed with a harpoon gun and a cutlass, sprang from the bushes bordering the road, and fired the gun at Corporal Burnette. The steel spear missed the officer, passed through the cab window, and grazed the driver's head.

The assailant then dropped the harpoon gun and resorted to his cutlass, slashing with it at Corporal Burnette. Despite a serious wound about the left knee, in a desperate effort Corporal Burnette managed to get out of the jeep and load his revolver. He fired the five rounds, four of which struck the assailant, who dropped the cutlass and disappeared into the bushes.

Corporal Burnette, who displayed such bravery, zeal and initiative in protecting life and property, bled profusely from his wound and was rushed to hospital; his assailant was eventually found lying helpless, bleeding from bullet wounds, and was later sentenced to five years' imprisonment with hard labour.
