PUBLIC SCHOOLS ACT 1868

THE GOVERNING BODY OF RUGBY SCHOOL having on the 25th day of November 1971, in virtue of the powers conferred upon them by the above-named Act, made a Statute in the terms appended hereto amending the existing Statutes of the said School, the said Statute is hereby published in the London Gazette in accordance with the provisions in that behalf contained in the said Act.

And notice is hereby given, that any person, body of persons or body corporate authorized in that behalf by the said Act, may, within two months after the publication of this notification, petition Her Majesty in Council to withhold Her approval from the whole or any part of the said Statute.

STATUTE AMENDING THE STATUTES OF RUGBY SCHOOL

THE GOVERNING BODY OF RUGBY SCHOOL at their Meeting on 25th November 1971, resolved that Statute XXII be amended to read as follows:

"No Scholarship shall be of the value of less than £40 a year nor of more than the Governing Body shall from time to time by Regulation determine. No Scholarship, other than a Benn Scholarship, shall be tenable together with a Foundation-ship."

DANGEROUS DRUGS ACT 1965

WITHDRAWAL OF AUTHORITIES

Clive Anthony Watkins

Whereas, Clive Anthony Watkins, B.D.S., of 10 Brayburne Avenue, London S.W.4, is, under Regulation 10 of the Dangerous Drugs (No. 2) Regulations 1964, authorised, subject to the proviso (i) to the Regulation, by virtue of being a registered dental practitioner, to possess and supply drugs and other preparations to which the said Regulations apply so far as may be necessary for the practice or exercise of his said profession;

And whereas the said Clive Anthony Watkins has been convicted of offences against the Dangerous Drugs Act 1965 and cannot in the opinion of the Secretary of State properly be allowed to remain a person as aforesaid:

Now therefore, in pursuance of Regulation 22 of the said Regulations, the Secretary of State hereby withdraws from the said Clive Anthony Watkins the authority aforesaid under the said Regulation 10.
