Whereas on the 28th April 1971 pursuant to the powers conferred by the above-mentioned Acts, the Secretary of State made an Order exempting Eagil Trust Company Limited whose address is 61 Grosvenor Street, London W.1, from the above Acts.

And whereas the Department of Trade and Industry in pursuance of section 123 (1) of the Companies Act 1967 have given a Certificate dated 19th November 1971 that they are satisfied that Eagil Trust Company Limited can properly be treated for the purpose of the Moneylenders Acts, 1900 to 1927 as being a person bona fide carrying on the business of banking.

Now therefore, the Secretary of State, in exercise of his powers under Regulation 10 of the Moneylenders (Body Corporate) Regulations 1927 by this Order revokes the Order exempting Eagil Trust Company Limited from the above mentioned Acts from the date hereof.
