CUSTOMS AND EXCISE

NOTICE OF SEIZURE UNDER THE CUSTOMS AND EXCISE ACT 1952

To:—Miss ANGELA MONTEIRO, P.O. Box 132, Jinja, Uganda, East Africa.

Pursuant to section 275 (5) of the Customs and Excise Act 1952, and paragraph 1 of the 7th Schedule thereto, the Commissioners of Customs and Excise hereby give you notice that by virtue of the powers contained in the customs and excise Acts and enactments amending those Acts, certain goods, namely One Hitachi Cassette Tape Recorder, One Small Speaker, One Yashica Camera with 45 mm. lens and One Akai Recorder with two speakers have been

seized as liable to forfeiture upon the grounds that the said goods were goods in relation to which the said Angela Monteiro recklessly signed a declaration on Form C3 for the purpose of an assigned matter namely customs which was untrue in a material particular in that it stated that the said goods had been used abroad for 13 months, whereas the period of use abroad was 6 to 7 months.

Whereby and by force of section 301 (3) of the Customs and Excise Act 1952 the said goods are liable to forfeiture.

If you claim that the said goods are not liable to forfeiture you must within one month from the date of this notice of seizure give notice of your claim in accordance with the said Schedule to the said Act. In default of such notice the said goods will be deemed to have been duly condemned as forfeited and will be liable to be disposed of in such manner as the Commissioners of Customs and Excise may direct. If you make such claim within the time aforesaid, legal proceedings will be taken for the condemnation thereof.
