3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000, and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being a multiple of one new half-penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House or Broker.

6. Notification will be sent on the same day as Tenders are received, to the person whose Tenders are accepted in whole or in part. *The Trunk Road (Newbridge Road, Newbridge)
(Restriction of Waiting) Order 1971*

Notice is hereby given that the Secretary of State has made an Order under section 1 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, the effect of which is to restrict waiting between the hours of 7 a.m. and 7 p.m. in that length of the Swansea-Manchester Trunk Road (A.483), known as Newbridge Road at Newbridge in the county of Denbigh, which extends from a point 49 yards south of its junction with Park Road in a general easterly direction to the eastern side of New Bridge (otherwise known as Dee Bridge), a distance of approximately 954 yards.

Exceptions have been provided in the Order to enable a vehicle to wait for so long as it may be necessary for a person to board or alight from the vehicle; to enable goods to be loaded on to or unloaded from the vehicle; to enable the vehicle to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance of the road or the authority in pursuance of statutory powers or duties.

If you wish to question the validity of the Order or of any provision contained therein on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968 or on the grounds that any requirement of that Act or of any instrument made under it, has not been complied with in relation to the Order, you may within six weeks from the 21st December 1971 apply to the High Court for the suspension or quashing of the Order.
