## DEPARTMENT OF THE ENVIRONMENT

### TOWN AND COUNTRY PLANNING ACTS 1962 AND 1968

The Secretary of State for the Environment hereby gives notice that he proposes to make an Order under section 153 of the Town and Country Planning Act 1962 and section 91 of the Town and Country Planning Act 1968 to authorise the stopping up of lengths of Derby Road and an unnamed highway together with certain unnamed accessways and footpaths in its vicinity, York Road and further unnamed accessways and footpaths in its vicinity, Maidstone Place together with neighbouring unnamed footpaths, two unnamed accessways between George Street and London Road, lengths of Albany Road and of an unnamed accessway within its vicinity and lengths of High Street at Grays, Essex to enable development consisting of a new town centre, car parks, a bus stand and public convenience to be carried out in accordance with planning permission granted under Part III of the Town and Country Planning Act 1962 and in the interests of the safety of users of and to facilitate the movement of traffic on the George Street—London Road Link, Maidstone Road—Crown Road Link and new roundabout in the Albany Road area which are highways to be constructed in accordance with planning permission granted under Part III of the Town and Country Planning Act 1962.

During 28 days from the 7th January 1972, copies of the draft Order and relevant plan may be inspected at all reasonable hours at the Thurrock U.D.C. Offices, Whitehall Lane, Grays, Essex and may be obtained, free of charge, from the Department of the Environment (quoting DE 45435/1/52) at the address stated below.
