

a vehicle to take in petrol, oil, water or air from any garage.

3. The restriction in 1 (b) above will not apply to vehicles which display a badge issued by a local authority to a disabled person as driver or passenger under section 21 of the Chronically Sick and Disabled Persons Act, 1970, and the Disabled Persons (Badges for Motor Vehicles) Regulations, 1971, or a badge having effect as if it were so issued.

4. A copy of the Order and a plan showing the lengths of road to which the Order relates, may be inspected at the offices of the Carmarthenshire County Council, County Hall, Carmarthen, during normal office hours.

Any person who desires to question the validity of the Order or of any provision contained in it, on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act, 1967, as amended by Part IX of the Transport Act, 1968, or on the grounds that any requirement of that Act or of any instrument made under it, has not been complied with in relation to the Order, may, within six weeks of the date on which the Order was made, apply to the High Court for this purpose.

SCHEDULE 1

Lengths of road in Cross Hands in the Rural District of Llanelli

1. Bryngwili Road A.476 along both sides for a distance of 90 yards from its junction with Trunk Road A.48.

2. Llandeilo Road A.476 along its north-west side for a distance of 77 yards from its junction with Trunk Road A.48 and for a further distance of 122 yards from a point 174 yards from its junction with Trunk Road A.48 to a point 63 yards north-east of its junction with Meadows Road.

3. Llandeilo Road A.476 along its south-east side for a continuous distance of 296 yards from its junction with Trunk Road A.48 to a point 63 yards north-east of Meadows Road.

4. Meadows Road Unclassified along both sides for a distance of 30 yards from its junction with A.476.

SCHEDULE 2

Length of road in Cross Hands in the Rural District of Llanelli

Llandeilo Road A.476 from a point 77 yards north-east of the junction of Trunk Road A.48 to a point 174 yards north-east of the said junction, a distance of 97 yards. (371)

CHESTERFIELD BOROUGH COUNCIL

The Borough of Chesterfield (Chatsworth Road/Old Road Junction) (Restriction of Waiting) Order, 1972.

Notice is hereby given that on the 5th day of January 1972 the Chesterfield Borough Council made an Order under section 1 of the Road Traffic Regulation Act, 1967, as amended by Part IX of the Transport Act, 1968, the effect of which is:

To prohibit (subject to the usual exemption relating to loading and unloading) the waiting of vehicles for a longer period than thirty minutes in any period of one hour between 8 a.m. and 6 p.m. on the following lengths of road:

Chatsworth Road (south side) west bound carriageway

(i) from the eastern boundary of No. 280 Chatsworth Road in a westerly direction to the eastern boundary of No. 298 Chatsworth Road;

(ii) from a point twenty yards west to the eastern boundary of No. 298 Chatsworth Road in a westerly direction to the eastern boundary of No. 324 Chatsworth Road.

No waiting at any time:

Chatsworth Road (north side);

From outside the eastern boundary of No. 255 Chatsworth Road for a distance of four yards in an easterly direction.

Exceptions are provided in the Order relating to the prohibition of waiting, so as to permit vehicles to wait to pick up and set down passengers, to load and unload goods, to carry out essential services or when used in pursuance of statutory powers or duties, or to take in petrol, water, oil or air at any garage situated on or adjacent to the length of road affected.

The Order will come into operation on the 10th January 1972.

A copy of the Order and a map showing the roads affected by it may be examined at the Town Clerk's Department, Town Hall, Chesterfield, between 9 a.m. and 5 p.m. on Mondays to Fridays.

Any person who desires to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act, 1967, as amended by Part IX of the Transport Act, 1968, or on the grounds that any requirement of that Act or of any regulation made thereunder, has not been complied with in relation to the Order, may, within six weeks from the 21st day of February 1972, make application for the purpose of the High Court.
