The Trunk Road (Carmarthen Road, Cross Hands) (Prohibition of Waiting) Order 1971

Notice is hereby given that the Secretary of State for Wales has made an Order under section 1 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, the effect of which is to prohibit waiting in that length of the London—Fishguard Trunk Road (A.48), known as Carmarthen Road, at Cross Hands in the County of Carmarthen, which extends from its junction with Woodlands Terrace to a point 240 yards north-west of that junction. of that junction.
