The Kent County Council (F.P. 8 (part) Chilham and F.P. 461 (part) Chartham) Public Path Diversion Order, 1971.

Notice is hereby given that on 30th December 1971, the Kent County Council confirmed the above-named Order.

The effect of the Order as confirmed is to divert the public right of way over that length of the footpath leading from Old Wives Lees to Chartham Hatch (F.P. 8 Chilham and F.P. 461 Chartham) from a point at the southern corner of Chestnut Plantation to the northern corner of the site of Bennett's Wood to a length of new footpath from the southern corner of Chestnut Plantation, north-eastwards for 1,000 feet, south-eastwards for 180 feet, north-eastwards for 800 feet, eastwards for 400 feet, north-eastwards for 300 feet, and north-westwards for 650 feet, to the northern corner of the site of Bennett's Wood.

LUDLOW RURAL DISTRICT COUNCIL

The Rural District Council of Ludlow (part of Footpath 8 in the Parish of Nash) Public Path Diversion Order, 1972.

Notice is hereby given that the above Order, made on 7th January 1972, is about to be submitted to the Secretary of State for the Department of the Environment for confirmation or to be confirmed, as an unopposed Order, by the Rural District Council of Ludlow.
