#### ROAD TRAFFIC REGULATION ACT 1967

##### *The Trunk Road (Various Streets, Ormskirk) (Traffic Regulation) Order 1972*

The Secretary of State for the Environment proposes to make an Order under sections 1 and 84D of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968.

The Order will re-enact with an amendment the existing restrictions on the North of St. Helens—Southport Trunk Road (A.570) known as Southport Road, Church Street, Moor Street, Derby Street West and Derby Street in the Urban District of Ormskirk, in the County of Lancaster.

The amendment will be to replace existing limited waiting with a restriction on waiting between 8 a.m. and 6 p.m. on the south side of Derby Street from a point 25 yards east of its junction with Burscough

Street to a point 25 yards west of its junction with Railway Road.

Exceptions will be provided in the Order to enable a vehicle to wait for so long as may be necessary for a person to board or alight from the vehicle, to enable goods to be loaded on to or unloaded from the vehicle, or to enable the vehicle to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance of the road or the services therein.

A copy of the Order, together with a plan illustrating the proposal, may be inspected during all reasonable hours at the offices of the Ormskirk Urban District Council at the Council Offices, Burscough Street, Ormskirk.

##### *The Trunk Road (Great North Road, Gosforth) (Prohibition of Driving) Order 1972*
