TOWN AND COUNTRY PLANNING ACTS
1962 AND 1968Notice of Public Path Order
Urban District of Alton, Hampshire

Notice is hereby given that the Secretary of State for the Environment, in exercise of the powers conferred on him by section 90 of the Town and Country Planning Act, 1968, section 153 of the Town and Country Planning Act 1962, and all other powers enabling him in that behalf, proposes to make an Order the effect of which will be to divert footpath No. 43 which runs from its junction with Orchard Lane, Alton, in an easterly direction to the south-western end of the terrace of houses known as River View, to a new line running from the aforementioned south-western end of River View in a north-westerly direction to Orchard Lane. The lines and situations of the existing and proposed alternative highways are shown on the map annexed to the draft Order.

A copy of the draft Order and the map contained in it has been deposited at the offices of the Alton Urban District Council, High Street, Alton, Hampshire, and may be inspected free of charge during normal office hours.
